#### 1. AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("The Podcaster") and Proven Grit Network, LLC, doing business as The Grit Podcast Network ("**Grit Podcast Network**", "**we**", "**us**", or "**our**"), concerning your access to and use of the http://www.provengritnetwork.com website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). We are registered in Rhode Island, United States and have our registered office at 210 Mountain Laurel Way, North Kingstown, RI 02852. You agree that by accessing the Site, you have read, understood, and agree to be bound by all of these Terms of Use. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. Revenue Share: Proven Grit and The Podcaster shall split all revenue derived from the sales of advertisements actually received by or irrevocably credited to Proven Grit or The Podcaster in accordance herewith from the exploitation of the Podcast Series ("Adjusted Gross Sales") as follows:

1.Sixty percent (60%) to Proven Grit and forty percent (40%) to The Podcaster.

2. Network sponsorships or sponsorships in relation to or associated with the Proven Grit Audio tag revenue share commissions are 25%

3.Payments are made by the 15th of the month for the previous month. You must have commissions of at least \$50 for a payment to process. Each month earnings will continue to rollover until they reach the minimum for payout.

# 1b. Advertisers Advertising, Marketing and Sponsorship.

a. Solely during the Term while on the network, The Proven Grit Network shall be the exclusive advertising sales representative for the Podcaster with a minimum of 4 ad slots and 1 Network Sponsorship (audio tag). The podcaster has the option to sell ads on his own behalf and shall coordinate any advertising sales efforts with Proven Grit in good faith. Podcaster keeps 100% of podcaster generated sales from their efforts.

b. Podcaster shall have the right to reject an advertiser and/or advertising copy at their reasonable discretion. Podcaster will use good faith efforts to provide Proven Grit with notice of its approval or of any objections to the advertiser and/or advertising copy within forty-eight (48) hours of receipt of such information from Proven Grit or such advertiser and/or advertiser copy.

c. Any use by Proven Grit of the Podcast Series and/or Podcaster's (or their affiliates') name(s), likeness(es), trademark(s), biograph(ies) or other intellectual property outside of what is permitted herein shall be approved in writing by the Podcaster.

d. In addition to the advertising sales set forth above, Proven Grit and the Podcaster agree to work together in good faith to market the podcast and sell mutually agreed sponsorship opportunities in the Podcast.

# 2. INTELLECTUAL PROPERTY RIGHTS

The arbitration shall be commenced and conducted under the Commercial Arbitration Rules of the American Arbitration Association ("AAA") and, where appropriate, the AAA's Supplementary Procedures for Consumer Related Disputes ("AAA Consumer Rules"), both of which are available at the AAA website www.adr.org. Your arbitration fees and your share of arbitrator compensation shall be governed by the AAA Consumer Rules and, where appropriate, limited by the AAA Consumer Rules. If such costs are determined by the arbitrator to be excessive, we will pay all arbitration fees and expenses. The arbitration may be conducted in person, through the submission of documents, by phone, or online. The arbitrator will make a decision in writing, but need not provide a statement of reasons unless requested by either Party. The arbitrator must follow applicable law, and any award may be challenged if the arbitrator fails to do so. Except where otherwise required by the

applicable AAA rules or applicable law, the arbitration will take place in United States Of America, Rhode Island. Except as otherwise provided herein, the Parties may litigate in court to compel arbitration, stay proceedings pending arbitration, or to confirm, modify, vacate, or enter judgment on the award entered by the arbitrator.

If for any reason, a Dispute proceeds in court rather than arbitration, the Dispute shall be commenced or prosecuted in the state and federal courts located in United States Of America, Rhode Island, and the Parties hereby consent to, and waive all defenses of lack of personal jurisdiction, and forum non conveniens with respect to venue and jurisdiction in such state and federal courts.
